AIILSG felicitated with prestigious RISK AWARD 2015

RISK AWARD

The RISK award is a joint initiative of The United Nations Office for DisasterRisk Reduction (UNISDR), Global Risk Forum, Davos and Munich Re Foundation, Germany.

Our innovation <u>'Community Self Assessment and Planning with</u>
<u>Women's Participation for Disaster Risk Reduction of Vulnerable</u>
<u>Communities'</u> was ranked first among 145 entries from 62 countries.

The award worth 90,000 Euro was announced at the 'Third UN World Conference on Disaster Risk Reduction' at Sendai, Japan on 16th March 2015.

The project is a global innovation as it addresses 3 aspects hitherto neglected vis-àvis disaster risk reduction: (a) Disaster Risk Identification and Assessment the Community there bγ empowering vulnerable urban slum communities to assess their own disaster preparedness & plan for disaster risk reduction. (b) Preparedness for Effective Response with special emphasis on participation of women & children who are among the most vulnerable to disaster impacts. (c) Knowledge Management and Education with special focus on developing child-friendly visual tools/ medium. The

pioneering grassroot implementation project will reach to atleast 25,000 slum dweller populations from 10 slums in Pune city. The global innovations being fostered through this Risk Award 2015 Project are: (a) self assessment & planning by the vulnerable slum communities to assess their own disaster preparedness and plan for disaster risk reduction (b) developing participatory & child friendly visual self-assessment and planning tools for the same, (c) gender sensitive disaster risk reduction planning by centre-staging the participation of slum dweller women who are worst affected by disasters, (d) Innovative IEC through creative communication mediums e.g. street play, puppet shows etc, (e) Developing innovative scientific and systematic tools like 'Slum Disaster Risk Reduction Plan' (f) establishing grassroot participatory mechanisms e.g. Slum Level Disaster Risk Reduction Committee, developing a cadre of community volunteers-cum-Master Trainers for enabling the sustainability of the initiative. "Right to Education with Right Education" Model for Under-privileged Children: supported by Govt. of India's National Stock Exchange Corporate Social Responsibility

Two Action Projects supported by Govt. of India's 'National Stock Exchange- Corporate Social Responsibility' "Serving and Enriching Education to Under-Privileged Children in Urban & Rural cum Tribal areas"

- Our innovative concept 'Right to Education with Right Education'a holistic model of education for bringing back childhood to the underprivileged children is supported by 'Government of India's National Stock Exchange-Corporate Social Responsibility'.
- The pioneering grassroot actions (through 2 action projects) are reaching more than 1600 under-privileged children from urban slums, rural & tribal areas and children of nomadic tribes.

The two action projects are based on a holistic concept model of 'Right to Education through Right Education' for under-privileged children from urban & rural cum tribal areas at four locations in Maharashtra. Both the project interventions focus on strengthening demand side as well as supply side of 'Right to Education' to improve access to and quality of education to the under-privileged children. The key innovations nurtured through both these projects are- (a) Children's Resource Center — 'Shikshan Ranjan Kendra' (b) Community based Interactive Library (c)

activity based learning, use of therapies (drama, music, drawing, craft) & personality development (d) established a cadre of 'Shikshan Mitras' for closely working with under-privileged children (e) establishing grassroot organisations for sustainability of the educational initiative e.g. 'Bal Panchayats' & Community Apex Body (f) Developing Pedagogy and Customized Educational Inputs and Methodology tailored to the needs of under-privileged children (g) exposure visits for children (h) Strengthening resources of the mainstream schools attended by the project children (i) Scholastic Counselling and Psychological Testing



United Nations Population Fund (UNFPA) supported project: 'Improving Health & Reproductive Health of Women and Girls from the Denotified and Nomadic Tribes (DNTs)'

In a rigid patriarchal society, the status of Denotified and Nomadic Tribal (DNT) women is highly precarious. The inhuman atrocities faced by these women and lack of access to basic services severely impact their health and reproductive health. Moreover there are hardly any studies focused on health status of DNT populations especially DNT women and girls in particular. This project addresses this hitherto neglected aspect and focus on improving understanding of the health and reproductive health needs of DNT women and girls. The current initiative with DNTs is spread over more than 181 settlements in 3 districts of Maharashtra state covering more than 24000 DNT population. The research findings in first year will lead to designing field interventions for improving health & reproductive health status of DNT women & girls. This project is a crucial step in long term social transformation

Reaching the Unreached: Empowerment of Nomadic Tribeswho are amongst the most under-privileged in the world

- <u>Huge Population of 110 mn in India</u> (more than population of 202 nations) living in extreme poverty, hunger & deprivation.
- Many Nomadic Tribes Communities still face Stigma of Criminality
- High Gender Inequality, women still facing inhuman medieval atrocities. E.g. social boycott and ostracism, forcing to walk through fire, balding the head, forcing to carry human or animal excreta, and even branding the tip of the tongue with hot iron.
- Nomadic Tribes Women most Vulnerable to Sexual & Gender Based Violence
- <u>Child marriages are common</u> and in some of the nomadic tribes, women are sold, mortgaged or leased out.
- Average literacy levels- 25%, Majority Children Out of School.
- Loss of Traditional Livelihoods

'Men for Women's Health' (MWH) Movement:

'Enabling Men to be More Responsible towards Women's Health'

An own initiative of AIILSG's International Center of EQUI-T, this movement is a path breaking approach for addressing gender inequality, violence against women, women's safety & security and their health & reproductive health issues. The movement adopts a holistic approach in appreciation of interconnectivity of women's health issues with economic participation, self reliance, decision making in wider societal context and empowerment.



Through 21 sensitisation programs the MWH movement has till now reached more than 7000 stakeholders of diverse types- Government Officials and Functionaries, Panchayati Raj Institutions, Civil Society, colleges, slums. 'Youth' are the key focus of this movement. To further the cause, a 'Cadre of Enablers' is developed who proactively reach to the stakeholders for engaging them in the movement. The innovative street plays & other modes of dissemination aim to sensitize the 'Men' esp. 'Youth' to bring attitudinal and behavioural change amongst themselves, creating awareness about domestic violence, safety & security of women & girls, women's reproductive rights, promoting use of contraception by men such as Non-Scalpel Vasectomy, sensitizing against gender based sex selection etc. The other crucial endeavours under the 'MWH' movement include- 'Training of Enablers on Reproductive Health', 'Sensitisaton & Awareness Generation Programmes' and 'Development & Dissemination of Sensitisation Kit and Resource Material on Men for Women's Health'.

'International Center for Women-in-Deprivation'

"Gender Equality & Women's Empowerment" is a priority issue for us. This commitment is reflected in an entity dedicated to the cause: 'International Center for Women-in-Deprivation'. The center focuses on the issues of inequality of women-in-deprivation" from urban, rural, tribal and nomadic tribes context.

The current priorities and key focus areas of this center are-

- Addressing Health and Reproductive Health Issues of Women-in-Deprivation due to lack of access to - health services, education, economic resources and assets, appropriate technologies etc.
- Mainstreaming & center staging role of women-in-deprivation in disaster risk reduction planning, environmental upgradation planning, climate change resilience & adaptation planning.
- Promoting financial literacy & financial management skills among Urban, Rural & Tribal 'Women-in-Deprivation'
- Promoting 'Appropriate Technologies for Women-in-Deprivation', Addressing Gender Gap in Technology,
 Developing a Cadre of Women Technopreneurs.
- 'Grassroots Gender Inequality Report': Bringing to fore issues of gender inequality, exclusion, lack of health, education & economic opportunities, violence against women etc.
- Promoting role of women-in-deprivation as 'Enablers' at community level for Environmental Education, Financial Literacy, Health & Nutrition, Livelihoods & Skills Development, Education of Children etc.
